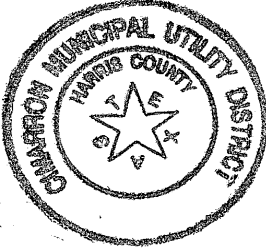
The Board of Directors of Cimarron Municipal Utility District will hold a regular meeting on Wednesday, June 17, 2020, at 12:00 p.m., **by teleconference* at (877) 402-9753, Access Code: 7731329**, to discuss and, if appropriate, act upon the following items:

1. Consider operations and service requirements relating to COVID-19 epidemic.
2. Receive public comments.
3. Approve Minutes.

5. Approve audit for fiscal year end February 28, 2020.
6. Financial and bookkeeping matters, including payment of the bills and review of investments.
7. Tax assessment and collections matters, including delinquent tax collections, installment agreements and payment of tax bills, and review of strategic partnership agreement revenues.
8. Authorize delinquent tax attorney to proceed with collection of delinquent taxes.

 - c. pay estimates, change orders and final acceptance of facilities, if any;
 - i. sanitary sewer rehabilitation, including Harris County pavement repair;
 - ii. hydro-pneumatic tank coating;
 - iii. fence replacement at water plant no. 2 and lift station no. 1;
 - d. utility commitment letters;
 - e. deeds, easements and encroachments; and
 - f. capital improvement and maintenance plan.
11. Storm water permitting matters.
12. Landscaping and trail reports, including approval of pay estimates, change orders and proposals for maintenance of landscaping and irrigation.
13. Pond maintenance and mowing report.
14. Operation of District facilities, including billings, repairs, maintenance, and utility bill messages.
